DOMESTIC AIRCRAFT INFORMATION SHEET

(Effective December 2022)

- Great Barrier Reef Airport – Hamilton Island (GBRA-HI) is a privately owned airport and prior permission to land is required.
- Air Traffic Control Tower operates on frequency 118.7 and is operational 7 days a week. Hours of operation are available by NOTAM. Outside of Tower hours, the area operates on CTAF 127.85.
- Runway lighting is manually activated and additional charges apply for lighting and callouts between the hours of 4pm and 7.30am by the Airport Safety Officer.
- Charges for fuel are separate and additional. Whitsunday Aviation Refueling is the agent for GBRA-HI. For further information on their charges, please contact:

- Once GBRA-HI has received, processed and approved your landing application; you will receive notification indicating your authorised parking location.
- GBRA-HI fees and charges will be charged by AVDATA Australia, for which you will be invoiced direct.
- Upon the receipt and approval of your landing application form, once processed all fees will become non-refundable.
- Hamilton Island Air (HIA) parking and facilities charges are separate (see 3rd page).
