#### **DAMAGE WAIVER**

Acceptance of the Damage Waiver removes financial liability for accidental or non negligent related damages to all registered drivers (conditions apply).

The waiver DOES NOT apply to damage caused by the driver to third party property or third party injury.

The damage waiver will be deemed void if the driver is found to have been in breach of the Hamilton Island rules and regulations, Queensland road rules or have been deemed to have acted in a negligent manner.

In the case of an incident resulting in damage, if the Damage Waiver is deemed void the registered driver will be held liable for the full cost of repairs to the buggy.

All incidents and or accidents are to be reported using the phone numbers attached to the buggy key tag. Failure to report an incident/accident will result in the damage waiver being void.

# This damage waiver excludes Hamilton Island Holiday Homes owner buggies.

## **CONDITIONS OF RENTAL**

- All nominated drivers must present a valid driver licence and undergo a safety demonstration prior to rental (minimum driver age is 21).
- All details and photo must be clear and legible for the licence to be considered valid.
- A credit card must be provided as security against damage and other charges.
- A buggy returned earlier than the original contracted time is non refundable.
- Your buggy is installed with a tracking system and as such will be monitored on a regular basis.
- The maximum payload for a golf buggy is 364kg.
- The maximum persons on a buggy is 4 people.
- · All occupants of the buggy must be wearing their individual seatbelt at all times.
- All Hamilton Island Holiday Home buggies are to be returned by 10.00am on checkout or will result in an overdue fee.

## **BUGGY OPERATING RULES AND REGULATIONS**

- Both Island Security and QLD Police actively enforce the road rules on Hamilton Island.
- Only nominated drivers are permitted to operate the buggy.
- · All accidents, incidents or breakdowns must be reported immediately to Island Security by using the numbers provided on the key tag.
- Open alcohol is not permitted on the buggy at any time.
- Ignition keys must be removed when the buggy is not in use to prevent it being stolen. Loss of a key will incur a charge of \$150.
- Hamilton Island does not permit any vehicles to be driven between 1.00am and 5.30am.
- Any costs incurred as a result of damage to the buggy, 3rd party persons or property, are the responsibility of the hirer.
- All damages will be applied to the nominated driver (unless Damage Waiver was accepted and conditions adhered to).
- Management reserves the right to refuse rental or confiscate a buggy in the interest of public safety and all payments will be forfeited.

## CHILD SEATS/CAPSULES

Queensland legislation states that all children under the age of 6 months are to be seated in a baby capsule facing towards the seat it is mounted to. A child 6 months to 4 years is to be in a child seat facing the same direction as the seat it is mounted to. This is subject to the amount of engineer approved restraint mounting points the buggy comes equipped with. The seats will be fitted by trained staff and should remain secured to the buggy for the duration of the rental. Securing and adjustment of straps in the capsule to fit the child is the responsibility of the parent or guardian (hirer).

### IMPORTANT SAFETY NOTICE

The hirer is responsible to recheck capsule anchorage points and adjust straps securing the capsule to the seat each time the child is placed in the capsule restraint. Capsule covers cannot be used when the child is positioned in the capsule.

## **BUGGY RELOCATION**

A non refundable fee of \$10 is applicable to every buggy that is hired at one location and returned to a different buggy hire managed outlet. Buggy relocation is not available to Hamilton Island Holiday Homes guests.

## AGREEMENT OF HIRE

# **Traffic Offence Penalties**

Hamilton Island golf carts are motor vehicles, driven on roads under Queensland law. There are significant penalties under Queensland law for contravening road rules. Some of these are outlined below:

Offence	Penalty
Not wearing a seatbelt (driver)	Fine of \$1078 and 4 demerit points
Not wearing a seatbelt (passenger over 16 years)	Fine of \$1078 and 4 demerit points
Passenger not wearing seatbelt (driver) The driver is liable for any passenger who does not wear a seatbelt or appropriate restraint	Fine of \$1078 and 4 demerit points (for each unrestrained passenger)
Child not properly restrained (on a lap or not in an appropriate child restraint)	Fine of \$1078 and 4 demerit points (for each unrestrained child)
Drink driving	Must attend court proceeding on mainland
Open licence holder - 0.05 or more BAC Provisional licence holder -	Maximum penalty of nine months imprisonment or a fine exceeding \$3,736
over zero BAC	Maximum licence disqualification of 2 years
Drug driving	Must attend court proceeding on mainland Maximum penalty of nine months imprisonment or a fine exceeding \$3,736 Maximum licence disqualification of 2 years
Driving without a valid driver licence	Must attend court proceeding on mainland Maximum penalty of one year's imprisonment or a fine exceeding \$5,338
Driving on the wrong side of the road	Fine of least \$106 and 2 demerit points
