DOMESTIC AIRCRAFT INFORMATION SHEET

(Updated February 2021)

- Great Barrier Reef Airport – Hamilton Island (GBRA-HI) is a privately owned airport and prior permission to land is required.
- Air Traffic Control Tower operates on frequency 118.7 and is operational 7 days a week. Hours of operation are available by NOTAM. Outside of Tower hours, the area operates on CTAF 127.85.
- Runway lighting is manually activated and additional charges apply for lighting and callouts between the hours of 5pm and 7am by the Airport Safety Officer.
- Charges for fuel are separate and additional. Whitsunday Aviation Refueling is the agent for GBRA-HI. For further information on their charges, please contact them on Mobile: 0412 936 177 or Email: warhamiltonisland@bigpond.com

Air Service Landing Fee and Passenger Service Fee are per arrival and per departure.

NB: Please note parking of aircraft is at the owner's risk and no responsibility will be taken for any damage to aircraft whilst parked at the Great Barrier Reef Airport.

Additional Charges

After hours arrival or departure

After hours arrivals or departures will incur an after hours call-out fee of \$300.00 (GST exclusive) per hour, with a minimum charge of 1 hour, between the hours of 5pm-7am.

Runway Lighting

This requires manual activation by the Airport Safety Officer.

Any operations between the hours of 5pm-7am require prior notice and additional charges will apply.

Price is \$100.00 (GST exclusive) per hour for lighting, with a minimum charge of 1hour.

Aircraft Parking

Jet Aircraft and Turbo Prop Aircraft parking on the main RPT Apron (Bays 1-7) or Western Apron, over 60mins duration.

Price is \$300.00 (GST exclusive) 1st day and \$100.00 (GST exclusive) each day thereafter.
