有效期: 2022 年 4 月 1 日 - 2023 年 3 月 31 日

FIT 预定

1 - 5 间房间，预定时需要提供姓名，更改客人名单将收取费用。

定金 & 付款

- 预定时支付 100% 的费用。

取消 & 更改

- 入住前 14 天之外，免费取消或更改。
- 入住前 8 - 14 天内取消或更改，按合同价收取订单全额 20% 违约金。
- 入住前 7 天内取消或更改，客人没出现或提前离开，按合同价收取全额费用。

节假日政策 (2022. 12. 21 - 2023. 1. 7)

- 预定时支付 100% 的费用。
- 2022. 10. 31 前取消或更改，即使部分入住期属节假日，按合同价收取订单全额 20% 违约金。
- 2022. 11. 1 日起取消或更改，客人没出现或提前离开，即使部分入住期属节假日，按合同价收取全额费用。

中国新年政策 (2023. 1. 16 - 2023. 1. 29)

- 入住前 21 天或以外取消或更改，即使部分入住期属新年，按合同价收取订单全额 20% 违约金。
- 入住前 14 天内取消或更改，客人没出现或提前离开，即使部分入住期属新年，按合同价收取全额费用。

定金 & 付款

- 预定 14 天内支付订单全额 20% 定金。
- 入住 28 天前支付取全额房费。

取消 & 更改

- 淡季 - 非澳大利亚学校假期
 - 入住前 21 天内取消或更改，按合同价收取订单全额 20% 违约金。
 - 入住前 14 天内取消或更改，客人没出现或提前离开，按合同价收取全额费用。
- 旺季 - 澳大利亚学校假期
 - 入住前 28 天内取消或更改，按合同价收取订单全额 20% 违约金。
 - 入住前 21 天内取消或更改，客人没出现或提前离开，按合同价收取全额费用。
- 特殊情况 - 其他会议等团队
 - 入住前 60 天内取消或更改，按合同价收取订单全额 20% 违约金。
 - 入住前 42 天内取消或更改，客人没出现或提前离开，按合同价收取全额费用。

Deposit & Cancellation Policy

Validity: 1st April 2022 to 31st March 2023

FIT Bookings

1 to 5 rooms, Names upon booking, Name change chargeable.

Deposit & Payment

- 100% full payment is required at time of booking.

Cancellation

- Cancellations or amendments received outside of 14 days prior to arrival will not incur a cancellation fee.
- Cancellations or amendments received within 8 - 14 days of arrival will be subject to a cancellation fee of 20% of the total booking value at the contracted rate.
- Cancellations or amendments received within 7 days of arrival, 'No Shows' and or 'Early Departures' will be subject to a cancellation fee of 100% of the total booking value at the contracted rate. i.e.: penalty will equal total booking value.

Festive Season Deposit & Payment Policy (booking incorporating 21 December 2022 – 7 January 2023)

- 100% full payment is required at time of booking.
- Cancellations or amendments received up to and including 31 October 2022 will be subject to a cancellation fee of 20% of the total booking value at the contracted rate, regardless of whether booking dates partially fall in Festive Season.
- Cancellations or amendments received from 1 November 2022, 'No Shows' and or 'Early Departures' will be subject to a cancellation fee of 100% of the total booking value at the contracted rate. ie: penalty will equal the total booking value, regardless of whether booking dates partially fall in Festive Season.

Chinese New Year Cancellation/Amendment Policy (bookings incorporating 16 – 29 January 2023)

- Cancellations or amendments received up to and including 21 days prior to arrival will be subject to a cancellation fee of 20% of the total booking value at the contracted rate, regardless of whether booking dates partially fall in Chinese New Year.
- Cancellations or amendments received from within 14 days of arrival, 'No Shows' and or 'Early Departures' will be subject to a cancellation fee of 100% of the total booking value at the contracted rate. ie: penalty will equal the total booking value, regardless of whether booking dates partially fall in Chinese New Year.

GIT Bookings

6 to 19 rooms, Names not required upon booking.

Deposit & Payment

- A deposit of 20% of the booking value is due within 14 days of confirming a group booking
- Full payment is required no later than 28 days prior to check-in

Cancellation

- **Low Season – Basically during non Australian school holiday**
 - Cancellations or amendments received up to and including 21 days prior to arrival will be subject to a cancellation fee of 20% of the total booking value.
 - Cancellations or amendments received from within 14 days of arrival, 'No Shows' and or 'Early Departures' will be subject to a cancellation fee of 100% of the total booking value.
- **High Season – Basically during Australian school holiday**
 - Cancellations or amendments received up to and including 28 days prior to arrival will be subject to a cancellation fee of 20% of the total booking value.
 - Cancellations or amendments received from within 21 days of arrival, 'No Shows' and or 'Early Departures' will be subject to a cancellation fee of 100% of the total booking value.
- **Special - Other conferencing group booked and confirmed**
 - Cancellations or amendments received up to and including 60 days prior to arrival will be subject to a cancellation fee of 20% of the total booking value.
 - Cancellations or amendments received from within 42 days of arrival, 'No Shows' and or 'Early Departures' will be subject to a cancellation fee of 100% of the total booking value.
